



Annual Golf Pass Information & Application

General Information

An Annual Pass-holder may play golf any day of the week for one year from the date of purchase. Also, an Annual Pass-holder receives access to the Short Game Practice Area. The Pass is non-transferable and non-refundable. The Individual and Family Pass purchaser may select from two payment options:

- 1) Payment in full on the date of purchase 2) 12-month payment plan

The Pass Holder agrees/understands:

1. The Pass is valid for one year from the date of purchase.
2. The Pass is non-transferable and non-refundable.
3. The Pass does not guarantee a tee time or access to the golf course or Short Game Practice Area. Tee time availability may be affected by course maintenance, events or course closure (i.e. sever weather). Tee time reservations recommended.
4. All RiverRidge and golf course rules will be followed. This includes but is not limited to:
 - a) Provide picture ID at Golf Shop prior to any golf round.
 - b) Play the golf course in golf hole sequence unless approved by the marshal or Golf Shop staff.
 - c) Play one golf ball in a round. Limit practicing to designated facility practice areas, e.g., driving range, putting greens, Short Game Practice Area.
 - d) Safely operate golf cars with no more than two riders. The driver is 18 years or older with valid driver's license and adheres to seasonal rules of golf car etiquette, e.g., cart paths only during winter months, always remain on cart path at tee boxes and greens.
 - e) Assure golfers in the Pass-holder's playing group check in and pay correct green and cart fees at the Golf Shop.
 - e) Purchase all alcoholic beverages at RiverRidge and comply with facility and Oregon Liquor Control Commission policies.
 - f) Comply with the USGA Rules of Golf: Rule 1.2: Standards of Player Conduct. This section discusses acting with integrity, showing consideration to others, and taking good care of the course.
